House Bill 256 - Passed
State of New Mexico

The Dee Johnson Clean Indoor Air Act went into effect in June 2007. This act is a comprehensive policy that bans smoking in most public places and workplaces in New Mexico.

On **April 3, 2019**, the **Dee Johnson Clean Indoor Air Act** expanded to include **prohibiting the usage of e-cigarettes**.

E-cigarettes will also not be allowed to use in smoke free areas such as:

- Enclosed buildings
- Workplaces
- Private residences that operate as a child care facility, adult care or health care or any combination of those activities

Along with the highly addictive substance Nicotine, e-cigarettes also release aerosol that contains ultra fine particles harmful to an individual's health; potentially cancer causing.

The changed policy will go into effect on June 14, 2019.
